

Another legislative session has ended. None of our bills were successful. The only thing that was passed that will help retirees is the elimination of taxes on social security. This bill will exempt 35% of social security tax the first year, 65% the second year and 100% in the 3<sup>rd</sup> year. **Retirees will see a 10% increase in PEIA premiums effective January 1, 2025, no changes in benefits nor does it affect spouses of retirees.** We will no longer have the annual Leadership Conference nor the regional meetings. Instead, we are planning a new meeting in four areas of the state. You voted to adopt this new plan, so we created WVARSE Leadership HUBS (Helping Units Be Successful)! These meetings will be in the following areas on the designated dates:

June 4 – Trinity Evangelical Lutheran Church Charleston, WV

June 5 – Beckley United Methodist Temple Beckley, WV

June 11 – West Virginia Eastern Community and Technical College Moorefield, WV

The community service project was for the Adam's House (food pantry). Karen Vuranch of Fayetteville, WV, a member of the WV Humanities Council - History Live, portrayed the infamous Pearl S. Buck and enlightened the audience on the life of times of a favored WV daughter. Pearl S. Buck was born in WV, grew up in China, a daughter of missionary parents, who embraced the culture but continued to hold tightly onto her West Virginia roots. Ms. Buck received a Pulitzer Prize for her 1931 novel, The Good Earth and was the first American woman awarded the Nobel Prize for literature. She was a humanitarian and social activist who had a deep concern for the welfare of children worldwide. Following her performance, Ms. Vuranch opened the floor for questions from the audience. Her knowledge of her character was deep and her portrayal convincing as you stepped back in time walking through Buck's life story.

WVARSE is the only organization that represents ALL retired school employees. I hope to see you in June.

### Legislative by John Taylor

It was a loooong 60 days and as often happens it came down to the last night. The AARP Advocacy Team was called into the Senate President's Conference Room to talk about our support for efforts to get the Social Security Tax Exemption bill moving. That shows the importance of our alliance with AARP. The Social Security bill passed the Senate at about 8 PM Saturday night, then had to go back to the House for completion. The passage of that bill was a great victory for older West Virginians, including a number of WVARSE members. Basically, single folks under \$50K and couples under \$100K are already exempt. For the rest, the bill will exempt 35% of Social Security the first year, 65% the second year and 100% in the 3rd year. The bill will be retroactive to January 1<sup>st</sup> of this tax year, and takes effect for the 2024 tax year. West Virginia was one of only 10 states that still charged income tax on Social Security. During the session, I made several contacts planting the seed for a COLA for our older members. Hopefully, this will be in the works

for future years. In other AARP news, the Unfair Real Estate Service Agreements bill passed. It will prevent realtors from paying for agreements to be an agent for people, putting a long term lien on their property, then making their heirs pay a percentage of the value of the property to inherit or sell the property. The WV realtors were behind us in passing this bill. The practice hadn't yet started in WV, but now we will be protected. Other AARP backed bills that passed were the WV Veterans' Home Mortgage Program and the bill to create a Physician Assistant Compact which will help to speed licensing of out of state PAs to come into WV. We lost a couple of fraud bills, including our robocall bill and our gift card scam bill, but all together it was a pretty successful year.

### Instructions concerning "Aging In"

When a PEIA member "ages into" the plan with a Medicare-effective date after January 1 and before 12/31, they are put into a Special Medicare Plan that has Original Medicare as primary and the PEIA coverage through UMR secondary. Express Scripts will service the RX benefit under the Special Medicare Plan as well. This is done to prevent any financial impact on the deductibles and copayments they may have already paid. The one area of caution that members need to be aware of under the Special Medicare Plan is the non- preferred drug or Tier 3. The charge for that is 75% coinsurance versus a 50% coinsurance under Humana. Members have a choice at the effective date of Medicare. They can move directly to Humana but must complete a transfer form with PEIA. Remember that all deductibles, out of pocket maximums and copays start over if you move to Humana.
