LEGISLATIVE GOALS 2021

These are our goals for the 2021 Legislative session.

- 1. That WVARSE will promote legislation to continue and maintain the quality of PEIA coverage, without increases in premiums, copays, or reduction in benefits.
- 2. That WVARSE will promote Legislation to provide a stimulus check of \$500 to each retiree that retired 20 or more years ago when a state of emergency is declared for a pandemic.
- 3. That WVARSE will promote legislation to increase the pension of those who retired 20 or more years ago by two dollars per month per year of service.

4. That WVARSE will support AARP efforts at the legislature.

It is looking more and more like that first goal just may be the one we need to work on the most for this session. The PEIA Board has said that next year will still be staying the same, but future years are problematic without infusions of cash.

We don't know what this Legislative Session is going to look like. There may be limited access due to COVID. What we do know is that grass roots efforts may just be our best bet. Sign up with your County Legislative Chair. If you don't know them, contact your local President. Get Geared up for the Legislative Session. This is a call-to-action!!! The contacts you make may just make a difference.

Our Tele-Townhall on October 20th was a success. We got rave reviews from NRTA and AARP thanking us for the collaboration. We should try to build on this collaboration to find ways to grow the WVARSE. This is a good step in the right direction

Watch for an email from me when they are available online. We now have three ways to pay membership dues. 1. Pay the conventional way by paying State and Local dues to the

unit membership chair. 2. Dues Deductible. Complete a dues deductible form (printed in this issue) with the last four digits of your social security number and signature. This allows TRS to deduct \$1.67 per month from your pension income. This is a convenient way of paying dues with no worry. Dues will be paid as long as you live. 3. Go to our website (WVARSE.org) and click on "Membership" on the next page find "pay online" and click it. Complete the form and pay either by Credit/ Debit card or a withdrawal from your checking account. Membership is important to our organization.



GILMER COUNTY


