Executive Director's Column



We welcome John Riddle (Jackson County), a WVARSE past-president, as Regional Director for Region III and Libby Casto (Nicholas County), a past WVARSE Secretary as Regional Director of Region V. Both have big shoes to fill. Melinda Walker and Ann Pauley did a great job as Regional Directors. We still need a Regional Director for Region I. Teresa Taylor did a great job and I am sure she is being missed by the counties in Region I. We hope someone in Region I will step up and take the duties of Regional Director. Duties for Regional Director were reduced by action taken at the 2023 Annual Council when Leadership Conference and Regional Meetings were eliminated. We are planning four leadership meetings in four areas of the state. We have not yet determined what these meetings will be called, but we have determined when and where they will be conducted. The first meeting will be conducted in Charleston at Trinity Lutheran Church. The second meeting will be conducted in Beckley at the Beckley United Methodist Church. The third meeting will be conducted in Moorefield at the West Virginia Community and Technical College. The fourth and last of these meetings will be conducted in Shinnston at Lincoln High School. More information will be shared concerning these meetings later. You may attend your choice of the four meetings. These will be conducted in one day. A registration form will

be sent out the early part of May, 2024 with a return date of May 25, 2024. This date is critical and must be observed. We will be providing lunch and must have an accurate number of attendees. Having your email and phone number on our membership file is an asset. We have sent emails to members using this several times. Remember life dues increased to \$150, effective July 1, 2023. We must continue to increase our membership. It is the responsibility of each member to do his/her best to enroll new members and retain old members. We still accept the old enrollment forms and members can enroll on the website. We have had a great response to our member list with names, addresses and phone numbers. We are working on getting these corrected. We have found quite a few discrepancies, and we will work with each unit to make corrections. You are now able to pay your membership dues online by using a credit card or a check draft. Go to www.WVARSE.org, click on membership, and then click on join online.

I am pleased with how the resolution of Jefferson County unit was handled. A letter was sent to current members asking them to continue membership in WVARSE. Betty Walter enclosed a membership form and gave them the address of our membership clerk. I am not pleased that they dissolved, but it was well-handled. I encourage county units to seek help if they are having trouble in finding members willing to take leadership roles. Contact your regional director and work with them in seeking a resolution. Your sharing of email addresses with us would be most helpful. Many of my email addresses are not valid. Legislative News

When the leaves start falling it's time to gear up for the next legislative session. While they are still home, you should be in contact with your legislators. Give them a copy of our goals and let them know that they have constituents that are paying attention to what they do. Your contacts now will make it easier to lobby them when they do get to Charleston. There are two things we really need to plant into their minds prior to the session. The first is PEIA. Our premiums are slated to go up in January of 2025 and for the next several years. Now is the time to take action to prevent this. Action MUST happen this year. The talking points you need are that we are, unlike the actives, on a fixed income. There are no raises to help supplement our pensions and cover the increased cost of premiums. Please pay attention to alerts for PEIA public hearings. They will be starting on the 6th of November and running through the 16th. It is important that we show up in numbers and wear RED to show our membership. We need to have folks present at EACH hearing and have an audience that shows our speakers support. The second is our request for a one-time supplement. Yes, we got something last year. However, it only covered the poorest 8% of our members. That's right, 92% of our members got nothing. Your legislators need to know several things. First, on behalf of those poorest members, we appreciate their help. Second, now we would like something that covers a broader number of retirees and is not limited to the poorest of us.

Your efforts will help our organization to make a difference. Don't ever discount the fact that one more contact may result in positive legislative outcomes.

2024 Legislative Goals

- That WVARSE will promote legislation to continue and maintain the quality of PEIA coverage, without increases in premiums, copays
 or reduction in benefits.
- 2. That WVARSE will promote legislation to increase the pension of those who retired 20 or more years ago by two dollars per month per year of service.
- 3. That WVARSE will support legislation to provide a one-time supplement of \$1,500 for retirees 70 and over who had at least 20 years of service.
- That WVARSE will support legislation to provide a Cost-of-Living-Adjustment or COLA for state pensions.
- **5.** That WVARSE will support AARP efforts at the legislature.

PEIA will conduct hearings for the 2024 year in November. Some of these may take place before you receive this newsletter.

It is proposed that Medicare retirees' premiums be increased 10% beginning January 1, 2026, with no change in premiums or benefits until then. However non-Medicare retirees are projected to have 10% increase in premiums, but no changes in benefits on July 1, 2025. Please try to attend one of these meetings.
