Our main goal is to seek a 1 percent severance tax on all deep sand gases. Proceeds from this tax will be devoted to public retirees. We added a goal of increasing the minimum pension benefit from \$500 to \$750.

This will affect only a small percentage of our retirees who well deserve the long-needed increase. As we go into the legislative session, we will need the support of the membership in getting these goals through. We hope you will be available to make calls, visits, etc. at a short notice.

throughout my term of office. Next, I want to extend my sincere thanks to our past-president Jo Ann Harman for the shining example she has provided me and for the excellent advice she has given me. She leaves me big shoes to fill even if her feet are smaller than mine. Our Executive Director Bill Milam represents WVARSE well at all times; he has already begun to help me through the first weeks of my presidency. With his wife Darlene serving as Newsletter Editor and Nominating Committee chair, we get "two for the price of one" as she travels with him and helps in many other ways. I also want to thank all of my officers, board members, regional directors and committee chairs--both the outgoing

and the newly installed. I also want to welcome our new President-elect Irvin Scarberry; I look forward to working with him in the upcoming two years. My sincere thanks also go to the outgoing officers, regional directors and committee chairs for all the hard work they have given WVARSE. Your work is greatly appreciated, and we will value your continued support and advice as we move forward.

As I'm sure you are aware, we are in very troubling times with our PEIA insurance. Those of us who are covered by Medicare are fortunate because the PEIA director Ted Cheatham has announced that they have renewed the PEIA contract with Humana to administer PEIA/Medicare for the next two years without an increase in deductibles or co-pays.

I feel that this is very

good news for all the Medicare retirees. I also believe that this is due to those of you who took your valuable time to read the WVARSE talking points on this matter and used these points to testify at ALL of the PEIA Outreach Committee hearings this summer. Your comments were heard, recorded, and incorporated into the final report. One of our main points was the excellent service provided by Humana. My heartfelt gratitude to those of you who testified; you made the difference!

Having said that, we must be aware that our work is not yet done. Our members not yet old enough for Medicare are still in limbo since they are still basically covered by the same PEIA plan as the active employees. Governor Justice's Task Force has not yet completed its work;

therefore, we must continue to be present and vigilant at all the committee meetings. The Design and Cost Subcommittees must finalize their proposals to present to the entire Task Force who will then formulate their proposal to fix PEIA. Once this is completed, the final report will be presented to the Governor and the Legislature for action. Meanwhile, Governor Justice has announced that the actives will receive a 5% pay increase next year and that he will put \$100 million into PEIA. I caution all of you to remember that this proposal requires legislative action for it to become reality. I strongly suggest that you "Remember in November". Our new Legislative chair John Taylor has attended all of the sub-committee meetings but one that I attended; he has graciously served as my chauffeur for

all the meetings so that the WVARSE presence was there to remind the committee members that we are very concerned about this matter. We both plan to continue to attend these meetings in the future. As proposals evolve, we may need to call on you to contact legislators about the Task Force's proposals.

Besides my focus on protecting our insurance, I plan to continue to emphasize Membership--just as my predecessors did. Membership is the life-blood of our organization.

Remember that your spouse, significant other, children and even your friends and neighbors can be Associate members. With their membership, they become eligible for all the benefits that AMBA offers us. If we are to be effective lobbyists, we MUST increase our membership.

Legislators know that there are over 30,000 education retirees; when we say that we represent approximately 7,000 members, we lose credibility. Therefore, I have chosen as my theme for the next two years

SMILE — Seek Members In Locations Everywhere. The comedienne Tina Fey once addressed a graduating class. In her remarks she asked the graduates to not be among those who say, "Yes, I see we need to do something, but I can't help out." Instead she urged them to be among those who say, "Yes, I see we need to do something, and I will help out." I'm asking each of you to be the member who says, "Yes, I see the need for WVARSE to increase membership, and I will do my best to recruit at least one new member." When we do this, we will all be able to SMILE.


WVARSE/KCARSE member Pauline Shaver, a Kanawha County Schools Health Service retiree, served her country, but not in common fashion.

A Morgantown native, Pauline was asked to go into practice in Preston County because of the shortage of physicians. As a nurse practitioner, she was then encouraged to join the West Virginia Air National Guard to fill a need.

While in the Guard Pauline was promoted to full Colonel, becoming the first woman in the state to achieve the rank within the Guard. She was also WVANG's first certified OSHA military officer.

She and her daughter Joy were the first mother-daughter members of any National Guard service in the country and the first mother-daughter charter members of the Women's Memorial in Arlington VA. Joy earned a Bronze Star in Desert Storm.

In addition to the Guard, Pauline has contributed greatly to the Kanawha Valley, earning her the 2014 Jefferson Award for Public Service, known as the "Unsung Hero" medal. She was involved in the establishment of Hospice services in Charleston, helped establish a community health ministry through St. Mark's United Methodist Church, was the first Red Cross certified disaster nurse, and volunteered for medical missions in South America with Medical Ministry International for over 11 years. She continues to administer vaccinations on a volunteer basis.


