Executive Director's Column



ended with a plus for retirees. SB 237 provides a \$1,500 onetime supplement for retirees 70 and above who had at least 20 years of service and has a minimum pension of \$1,000 per month. We are pleased that our fellow retirees on the low end are being boosted. This bill also increased the minimum pension to \$1,000 per month. Prior to 2001

there was no minimum pension and we had some of our retirees making less than \$500. Through the efforts of our association a minimum of \$500 was established in 2001. That remained the minimum until 2019 when, under the leadership of WVARSE Legislative Chair John Taylor, it was increased to \$750. SB 237 increased it to \$1,000. Thanks to John our minimum pension has increased \$500 in the past 4 years. Four bills were completed during the 2023 Legislative session which affect PEIA: SB 268 mandated that the 80/20 rule be enforced, causing premiums to increase on all participants other than retirees, effective July 1, 2023. Retirees will see 10% increase in premiums effective January 1, 2025. There will be no changes in benefits nor does it affect spouses of retirees. SB 268 requires that the minimum level of reimbursement at 110% of the Medicare amount for

Another legislative session has all providers. It requires an annual fiduciary training and completion of conflict-of-interest forms in order to serve as a PEIA finance board member. Other items of this bill do not affect retirees. SB 577: reducing Copay on Insulin & Devices. HB 2029: repealing the Creation of an All-payer Claims Database.

> We will have a one-day Leadership Conference (May 3, 2023). We will have our regional meetings this year. We are debating having a normal 2-day Annual Council. The agenda for Leadership and the Regional Meetings schedule is addressed in separate articles in this Newsletter.

> We must continue to increase our membership. It is the responsibility of each member to do his/her best to enroll new members and retain old members. We still accept the old enrollment forms and members can enroll on the website. Effective July 1, 2023 Life Membership dues increases to \$150. Your sharing of email addresses with us would be most helpful. We prefer that you share your email address with your unit, and it will, in turn, share it with me. That way all concerned will have access. Many of my email addresses are not valid. Legislative News



WE DID IT!!! Your calls to the Governor's office got retirees on his radar and into the State of the State message. We asked you to make phone calls and you did. Grass roots efforts work. That resulted in Senate Bill 237. It is now completed legislation and has been signed by the Governor. Several of us were able to be at the Signing Ceremony for this bill. What it will do is give a \$1,500 13th check to retirees 70 and older who have at least 20 years of service and a monthly pension of less than \$1,000. That's an extra check of more than a time and a half their regular check. That affects 5,273 retirees. The bill also increases the minimum pension of retirees 70 years and older with at least 25 years of service from \$750 to \$1,000 per month. That affects 1,687 retirees.

The neediest of our retirees have now been taken care of. That is a great first step. Since I have been your State Legislative Chair, we have doubled the minimum pension from \$500 to \$1,000. We should be grateful to the

Governor and the

Legislature for helping our neediest retirees We should also appreciate the efforts of the AARP Advocacy Team that helped us accomplish this and the WVARSE members who are also part of that team. Thanks to Danny Gray, Bob and Nellie Orsburn, Ann Pauley, and Irvin Scarberry.

Now it is time to start working on broader coverage. When you consider there are over 66,000 retirees, 92% of us got left out. We want to work on something next year that gives something to the more average retiree. With inflation being what it is, the rest of us should get some meaningful relief as well.

The PEIA bill is a real problem for the actives and for our early retired members. Those retirees that are still on regular PEIA instead of the

Medicare Advantage plan will have to pay increased premiums without the benefit of the pay raise the actives will get. Those of us 65 and older, who are on the Humana Medicare, should not see a change for now. It is an ill wind that blows no good. At least the PEIA Bill improved insulin coverage to match the AARP sponsored insulin co-pay bill. Those who take two kinds of insulin will be charged as an aggregate with one co-pay for both types of insulin of no more than \$35 for a 30-day supply.

Medicare Advantage for Seniors

Rumors abound concerning funding for Medicare Advantage. WVARSE became aware that it was possible that CMS would reduce funding in the billions, Thanks to Tom Sussman, President Charmel Radcliff and Executive Director Bill Milam who participated in two zoom meetings with the staff of Senator Joe Manchin and Congresswoman Carol Miller. A letter, using WVARSE stationary under Charmel's signature, was sent to CMS and President Biden expressing concerns for WVARSE members. Copies were sent to each senators' office and each congressperson's office. Later a zoom meeting was scheduled with representatives of CMS and seniors from 12 states. Bill attended this meeting. It was noted in the meeting that West Virginia has 199,000 seniors enrolled in Medicare Advantage plans. This is equivalent to 43% of eligible Medicare Beneficiaries, the highest state percentage in the nation. 54,000 of those seniors are state and school retirees. Each state representative had the opportunity to tell his/her experience with Medicare Advantage and how reduction in funding would affect local participants. Bill told them Medicare Advantage was the best plan for West Virginia due to low premiums and rich benefits. He spoke of examples (personal and others) where seniors using Medicare Advantage had surgeries with very little outof-pocket expense and had follow-up contact with food, etc.. Bill was interviewed by WOWK-TV Channel 13 concerning this, where it was reported that reducing funding for Medicare Advantage would be disastrous for WVARSE retirees as well as other seniors because many can hardly afford the expenses of Medicare Advantage and definitely would have a difficult time managing a more expensive plan. CMS announced that there would be no reduction of funding for Medicare Advantage. The efforts of these Zoom meetings and the letters sent to President Biden and CMS were influential in the final decision




Roane County
